NOTES:

There is an increase of 30 Adult only Beds, and no change in Family Units and beds. This includes 18 VASH vouchers and 12 new beds at Liberty Place.

There is an increase of 15 dedicated Chronic Homeless beds and 18 Veteran beds. This is the first year we have included the VASH vouchers administered by the DuPage Housing Authority in DuPage. DuPage does not have any vouchers of their own at this time.

We see an increase of 9 people in PSH in the 2017 PIT count.

Catholic Charities - Partners In Housing (PSH)(6513) is actually showing combined values for DuPagePads - Partners In Housing (PSH)(6523) and Catholic Charities - Partners In Housing (PSH)(6513). DuPagePads - Partners In Housing reported a primary zip of 60516 and serves SMF, where as Catholic Charities reported 60559 and serves HC.

DuPagePads - Crossroads (PSH)(7149) is still pending a merge into Carol's Place in HMIS, but is in process. For the purpose of the HIC and PIT, data from these HMIS providers are manually merged together.
