**NOTES:**

Decrease of TH PIT persons by 229 and 248 beds, which is a direct impact of the removal of a Transitional Housing project who was determined to not meet the criteria for inclusion.

Bridge Transitional Housing has been assessed as not meeting the criteria for inclusion in the HIC/PIT and has been removed. For 1/25/17, they reported to have 267 Beds and 89 units, and their PIT count was 263 persons and 84 households, which was an increase from last year by 27 Beds and 42 people.

We are seeing an increase of 2 Youth Beds (Under 18) and 1 unit in a Parenting Youth project, Jubilee Village. This is the reinstatement of a previous unit made possible with renewed state funding.

The Youth Beds are being reported differently this year for Jubilee Village. The beds were not previously classified for the children in the household as beds dedicated to those under 18.
