The full DuPage County CoC Snapshot will return in the spring of 2021.



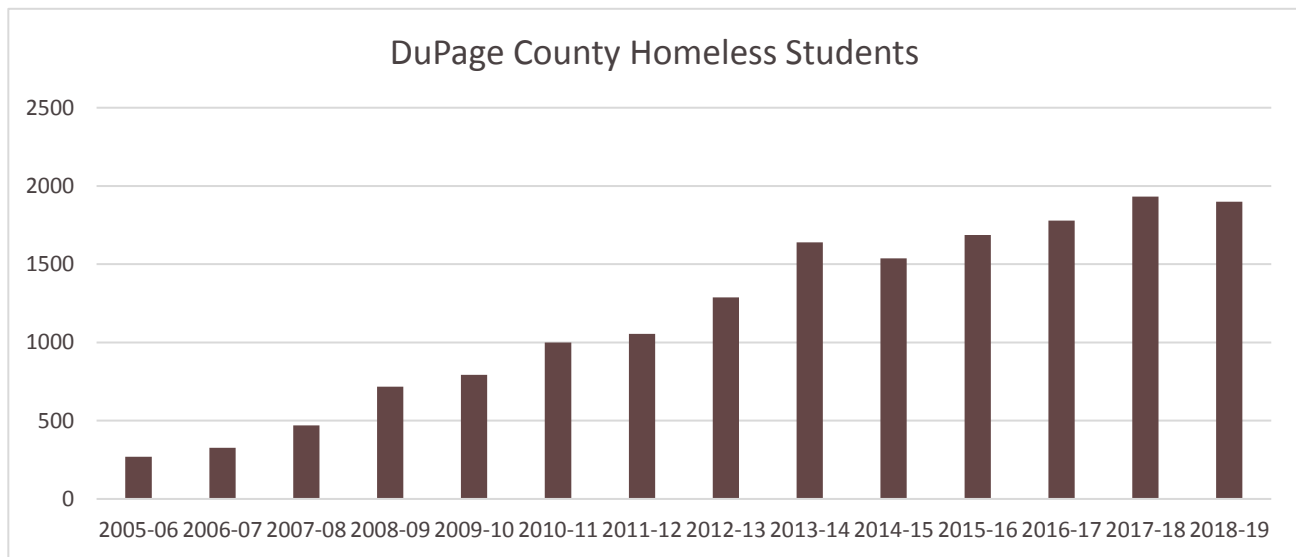
2019 DuPage County CoC Snapshot

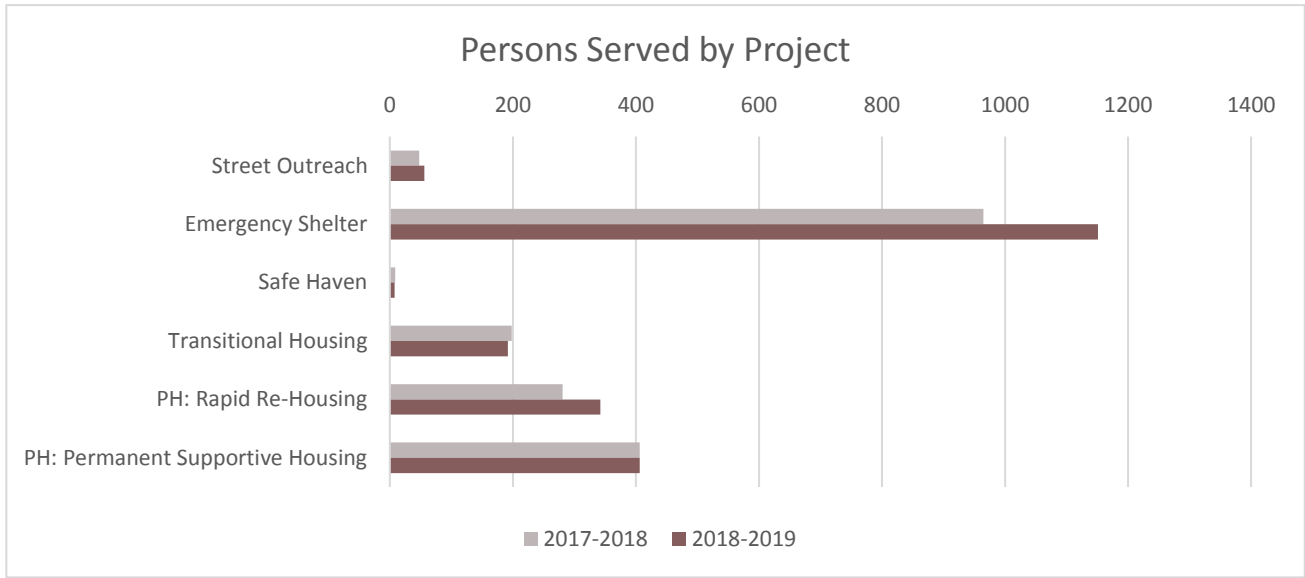

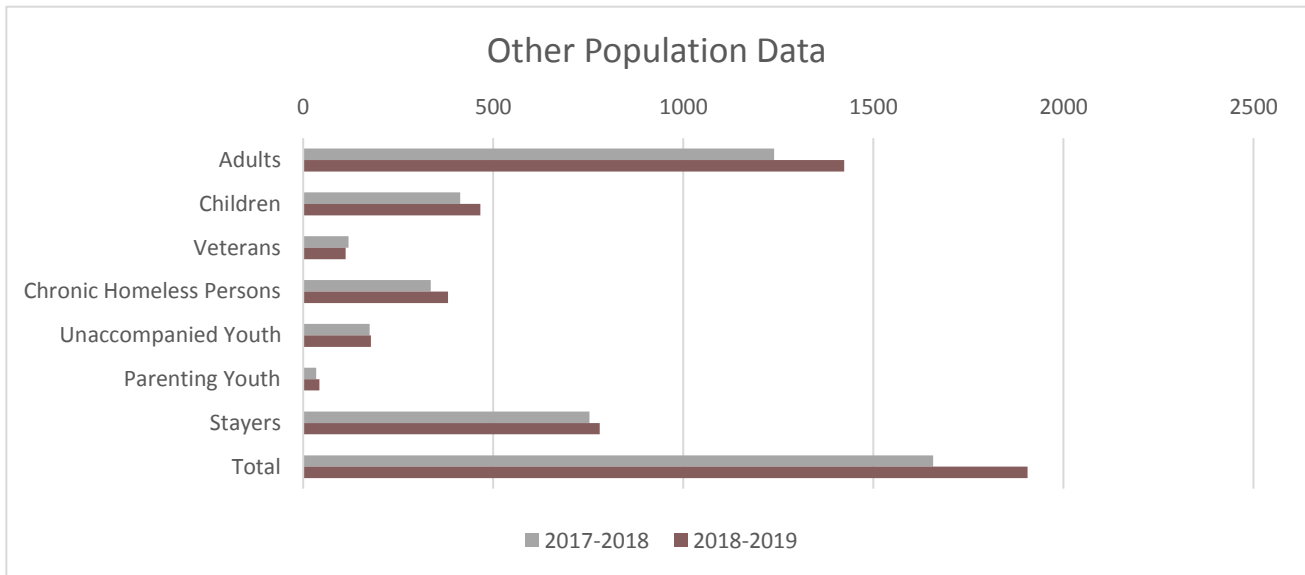

Persons Served by Project Type:



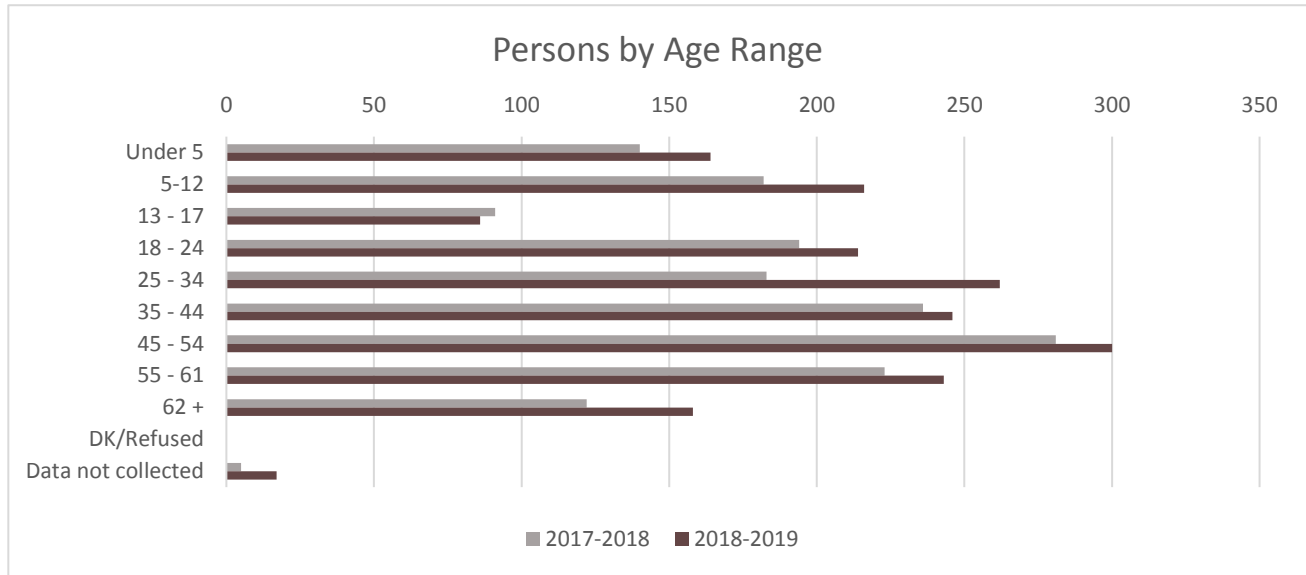

The DuPage County CoC has worked towards implementing adjustments to the way individuals experiencing homelessness access permanent housing (permanent supportive housing and rapid re-housing) with the goal of expediting housing placements as quickly as possible, ensuring our system remains flexible as we work to house those experiencing homelessness in light of COVID-19. The DuPage County CoC has developed a COVID-19 Rehousing Response, following guidance provided by local public health officials, as well as state and federal partners.
