Dear DuPage County CoC members,

Though the 2020 NOFA has not yet been announced by HUD, the DuPage CoC is following its regular project selection and review process of all projects recommended for funding as per the Notification notice of 9/1/2020. This will ensure an efficient and effective process once the NOFA is announced.

Project application templates for both new and renewal projects are attached to this email. Any organization that is recommended for FY2020 CoC funding must complete the appropriate Project Template for each project.

**Completed project templates are due on September 21, 2020 for all recommended new and renewal projects. Project applicants should email the template materials to Peg White Lijewski at [peglijewski@gmail.com](mailto:peglijewski@gmail.com) with a copy to [continuum@dupageco.org](mailto:continuum@dupageco.org).**

All applicants will receive written feedback via email on any corrections or revisions to the project templates no later than September 28, 2020. Renewal project budgets should utilize the final 2020 GIW amounts. New projects should utilize the recommended amounts on the Project Notification.

As soon as HUD communicates the 2020 NOFA, applicants will be notified of the deadline date for submission of projects in HUD's esnaps system. Any new project amounts that need to be modified will be notified by the CoC at that time to revise their new project templates.

The DuPage CoC deadline dates and announcements, all CoC application materials, the Project Templates and Ranking Criteria documents are also posted on the DuPage CoC website at <https://dupagehomeless.org/cocoverview/hud-nofa/>.
