Dear DuPage CoC members,

The 2021 HUD Notice Of Fund Availability (NOFA) for the Continuum of Care program was released on August 18, 2021.

All projects will be evaluated according to the 2021 ranking criteria approved by DuPage CoC Leadership Committee. These include a specific method for evaluating domestic violence projects. This Local Competition deadline announcement, all CoC application materials, the Project Templates and Ranking Criteria documents are also posted on the DuPage CoC website at <https://dupagehomeless.org/cocoverview/hud-nofo/>.

Project application templates for both new and renewal projects are attached to this email. **For any organization that is applying for FY2021 CoC funding, the appropriate Project Template must be completed for each project.** Deadlines for the Project Templates are below. NEW project amounts will be determined at the Leadership ranking and Tiering meeting on 09/15/21.

DUPAGE CoC DEADLINES

September 15, 2021 – All new project applicants will submit a project template to peglijewski@gmail.com and lisa.snipes@dupageco.org for evaluation.

September 22, 2021 – Each renewal project applicant will submit a project template peglijewski@gmail.com and lisa.snipes@dupageco.org for evaluation.

October 1, 2021 – Each project will submit their project in *e-snaps* for final review.

Esnaps submission of projects may be no later than 30 days before the HUD deadline of 11/16/21. The DuPage CoC will notify all project applicants no later than 15 days before the application deadline of November 16, 2021 whether their project application will be accepted and ranked, rejected or reduced as part of the CoC Consolidated application and of their number ranking. Project application deadlines and materials will be posted on <https://dupagehomeless.org/cocoverview/hud-nofo/>.
