Dear DuPage County CoC Members:

The DuPage County Continuum Leadership committee is starting the application and selection process for HUD's 2021 Continuum of Care funding for both new and renewal projects. While the amount of funds

available has not been announced, last year the DuPage County Continuum had an annual renewal amount of approximately \$5.0 million.

This is an open invitation to apply for funds in the 2021 competition. There are two attachments – the Notice of Funding Availability for 2021 and the CoC Application Schedule. Please read both for details on the rating and review process, meeting dates, and important deadlines.

As was the process last year, all applicants will be required to submit their documents through the internet based ZoomGrants.

There will be a two-step process. First, applicants will complete a short Project Performance Evaluation (PPE) questionnaire in ZoomGrants. The PPE questionnaire must be completed in Zoom Grants by February 25, 2021. Once approved, applicants will move forward to completing a Business Plan and Cost Forms. Please note although the Business Plan is currently visible to applicants in ZoomGrants, the final version may contain language changes when formally opened and available to approved applicants.
