The 2022 HUD Continuum of Care Notice of Funding Opportunity (NOFO) was announced on August 1, 2022. For your information, attached is a summary of the key points in the 2022 NOFO MEMO for the Continuum of Care application process. The attached 2022 NOFO Memo also contains detailed information on changes in the 2022 NOFO and links to HUD NOFO informational materials.

There are funds available for new projects through reallocation, CoC Bonus, and domestic violence bonus funds. The CoC bonus amount available is \$283,950. The amount available for Domestic Violence projects is estimated to be \$330,000
