Dear DuPage CoC members:

The 2022 HUD Notice of Funding Opportunity (NOFO) for the Continuum of Care program was released on August 1, 2022. **This year, the NOFO is operating on an accelerated deadline schedule.**

All projects will be evaluated according to the 2022 ranking criteria approved by DuPage CoC Leadership Committee. These include a specific method for evaluating domestic violence projects. This Local Competition deadline announcement, all CoC application materials, the Project Templates and Ranking Criteria documents are also posted on the DuPage CoC website at <https://dupagehomeless.org/cocoverview/hud-nofo/>.

Project application templates for both new and renewal projects are attached to this email. For any organization that is applying for FY2022 CoC funding, the appropriate Project Template must be completed for each project. Deadlines for the Project Templates are below. NEW project amounts will be determined at the Leadership Ranking and Tiering meeting on 08/24/22.

DUPAGE CoC DEADLINES

August 26, 2022 – All project applicants will submit a CoC project template to Peg White Lijewski peglijewski@gmail.com and Lisa Snipes Lisa.Snipes@dupageco.org for evaluation.

September 1, 2022 – Each project application must be submitted in e-snaps for final CoC review.

September 15, 2022 – Each project applicant is notified in writing if their project is accepted, rejected, or reduced on the CoC Project Priority Listing.

Esnaps submission of projects may be no later than 30 days before the HUD deadline of 9/30/22. The DuPage CoC will notify all project applicants no later than 15 days before the application deadline of September 30, 2022 whether their project application will be accepted and ranked, rejected or reduced as part of the CoC Consolidated application and of their number ranking. Project application deadlines and materials will be posted on www.dupagehomeless.org.

Project submission instructions for esnaps will be reviewed at an APPLICATION WORKSHOP scheduled for August 26, 2022 from 1:30 pm. – 2:30 pm. This is a Zoom meeting and attendees must register prior to the event. The link to register is below:
