The 2023 HUD Continuum of Care Notice of Funding Opportunity (NOFO) was announced on July 5, 2023. For your information, attached is a summary of the key points in the 2023 NOFO MEMO for the Continuum of Care application process. The attached 2023 NOFO Memo also contains detailed information on changes in the 2023 NOFO and links to HUD NOFO informational materials. There are funds available for new projects through reallocation, CoC Bonus, and domestic violence bonus funds. The CoC bonus amount available is \$438,104. The amount available for Domestic Violence projects is estimated to be \$295,692. There will be a **CoC VIRTUAL APPLICATION WORKSHOP** scheduled for Wednesday,

August 9th at 1:30 pm. The person who will be completing the application should be in attendance. **Please register in advance for this workshop.**
