4-2. Describe how the CoC determined that this project should be reduced and include the date the project applicant was notified of the reduction. (limit 750 characters)

There was a voluntary reallocation of one renewal project – Partners In Housing. Catholic Charities, Diocese of Joliet, requested to reduce their project from 32 units to 18 PSH units in order to reduce administrative and staffing burdens. The CoC agreed to this request and reallocated these funds to a new PSH project with DuPage PADS so that PSH capacity did not decrease. Since no other low performing projects were identified, only Partners In Housing was subject to reallocation this year.
