Updates	 Discussion around Agency Data Admin (ADA) role, intent of this meeting, requests to add people to these meetings, communication plan, and seeking input from the group. Feedback around meeting invites expanding beyond ADA includes: it helps to have other staff present (at the ADA training) due to different perspectives on information provided, helps to communicate information across all programs within the agency. Understood that the ADA will remain the single point of contact and will be expected to participate in these meetings and ensure updates are communicated through agency. Data and Performance Committee reviewing the Standard Operating Procedures (SOP) at the 2/21 committee meeting. This committee is also seeking a Committee Chair. We are proposing removal of the Certification Exam, focusing on providing more training resources and the user being able to demonstrate the standard data entry workflow. No concerns reported by the group, and feedback in support of this change. Proposed scoring changes for the HMIS portions of the CoC NOFO application process. If changes are approved by Rank and Review, they would not take effect until next year. National Human Services Data Consortium (NHSDC), 4/10-4/12, Kansas City, MO. Check in on the FY24 assessments and new/updated data elements. Concerns expressed regarding the sexual orientation field. Discussion around client centered assessment, client's right to decline to answer, and data will likely be used similar to race/ethnicity and gender, to help ensure fair practices. This field is reporting in the APR Q24C for Adults in PSH.

- ESG CV 1/30 State is behind on several reporting quarters and are pending a 3rd party review of their accounting before requesting data. County is completed.
- Longitudinal System Analysis (LSA) 1/24 We completed our report and received confirmation that the data review was completed by HUD TA. Data is available for viewing through <u>HUDHDX2.info</u>, through a free account. Accounts require approval via the CoC Lead.
- System Performance Measures (SPM) opens 2/12 and is due by 3/13.
- o **Point-in-Time (PIT)** and **Housing Inventory count (HIC)** due date to HUD not announced yet. Local count is scheduled for 1/31.
- <u>Data Dashboard</u> displaying Annual Performance Report (APR) data for all Street Outreach (SO, Emergency Shelter (ES), Transitional Housing (TH), Rapid Re-Housing (RRH), Permanent Supportive Housing (PSH) and other types of Permanent Housing (OPH) for the 2023 calendar year.
- SPM, PIT, and HIC reports are now going to be completed in <u>HUDHDX2.info</u>. Moving towards direct HMIS data exports and importing files into the reporting tools, like the APR and CAPER. Data corrections must be made in HMIS.

 - Due date for projects to submit their PIT reports to HMIS will be mid-February.
