

# NOTICE OF REQUEST FOR CONTINUUM OF CARE FUNDING PROPOSALS HUD 2024 CONTINUUM OF CARE HOMELESS APPLICATION PROCESS 02/02/2024

The DuPage Continuum Collaborative Applicant is starting the application and selection process for HUD's 2024 Continuum of Care funding. This is an open invitation to apply for funds in the 2024 competition for both funded and non CoC funded organizations. Applicants may apply for renewal or new projects. Renewal projects must apply for their current HUD award amount. The 2023 award amounts were announced by HUD on January 29<sup>th</sup>, 2024. Both current grantees and new agencies not previously funded may apply. This includes victim service providers with consideration of their data and the population they serve. Eligible project applicants include nonprofit organizations, states, local governments, public housing agencies and instrumentalities of state and local governments. For profit entities are not eligible. The only new projects that may be applied for are those described below. Expansion of an existing renewal project constitutes a new project. Please note only those applicants that apply for a new project will be considered for any bonus or reallocation funds which may become available when HUD makes their 2024 funding announcement. There are firm deadlines for submission of the required documents in Neighborly. All projects must complete a Project Performance Evaluation by February 23, 2024. All approved projects must complete a Business Plan and Cost Forms by May 1, 2024. The link to access the application forms in Neighborly is posted on <a href="https://dupagehomeless.org/">https://dupagehomeless.org/</a> and will also be emailed to the CoC membership. While the amount of HUD funds available has not been announced, last year the DuPage Continuum had an annual renewal amount of approximately \$6.2 million. In 2023, there was also a bonus amount of approximately \$438,000 for one or more new projects. There was also an additional bonus amount of \$366,000 for a new or expansion DV (Domestic Violence) project.

In this FY 2024 DuPage CoC funding process, applicants may submit requests for renewal projects and requests for new projects. Renewal projects must apply for their 2023 HUD award amount. In accordance with HUD guidance, the CoC will competitively rank projects. Each CoC must review all current projects to determine the extent to which each project is necessary and addresses the HUD policy priorities. Strategic re-allocation of resources is encouraged to further HUD policy priorities. All projects are subject to re-allocation. Reallocation is a process whereby a CoC reallocates funds in whole or in part from a renewal projects to create one or more new projects. All projects will be evaluated for reallocation both on performance and on expenditure of grant funds.

### **NEW PROJECTS**

New projects may be created through reallocation of current renewal funds, bonus funds, or a combination of reallocation and bonus funds.

## For all new projects other than Dedicated DV, 5 types of projects are allowed:

- Permanent supportive housing that serve chronically homeless or that meet the Dedicated PLUS definition.
- Rapid Rehousing projects that serve households who meet the homeless definition categories of 1, 2 or 4.
- Joint TH and PH-RRH component project that serve households who meet the homeless definition categories of 1, 2 or 4.
- Dedicated HMIS (only by the current HMIS Lead)
- Coordinated Entry (supportive services only) to develop or operate a coordinated entry system.

## **Domestic violence dedicated projects**

CoCs may create any of the following project types if the amount is at least \$25,000:

- Rapid Rehousing (PH-RRH);
- Joint Transitional Housing and Rapid Rehousing (Joint TH-RRH)
- Supportive Services Only-Coordinated Entry (SSO-CE) that targets victims of domestic violence. (only 1 such application is allowed).

The eligible population is survivors of domestic violence who are defined as homeless at 24CFR 578.3 (4). All DV projects must be for a grant term of 1 year. NOTE: Expansion of any existing RRH or Joint TH-RRH renewal that is non-DV will qualify as a new DV bonus if it exclusively serves DV person.

The term of all new projects may be 1, 2 or 3 years for leasing and 1-5 years for rent assistance. There is no match requirement for leasing, but there is a 25% match for Rental Assistance, Supportive Services, Administrative and Operating Costs. All renewal projects will be evaluated for performance and unspent funds. Renewals may apply to reallocate their project or to transition to another type of eligible project. This will then be considered a new project and subject to the HUD rules of new project selection.

Please note that Rapid Rehousing projects under the CoC program must have additional match since their leasing dollars will become rent assistance, will not be able to claim operating expense, and must have the leases in the client's name, not the agency's. CoCs may not reallocate administrative costs to create new projects.

Verbal presentations on <u>ALL NEW projects</u> and any <u>renewal projects with proposed changes</u> or <u>projects with questions from the preliminary project evaluation</u> will be held at the Gaps and Needs Committee meeting March 21, 2024. A list of all other renewals that met the PPE thresholds with no questions will be distributed for approval to move forward. <u>ALL PROJECT APPLICANTS ARE REQUIRED TO ATTEND.</u> The meeting will be held virtually using Zoom. Any ineligible new projects will be identified at this meeting. Unless a project clearly does not meet eligibility requirements, all new projects go to the next level and complete a Business Plan with Cost Forms.

All eligible projects must complete a full Business Plan and Cost Forms in the Neighborly internet based application system. These will be available on February 23, 2024. Please be aware that it is a competitive process.

The Business Plan and Cost Forms are due for submission in Neighborly by May 1, 2024.

Note: The Planning grant is not required to complete this application process because it is an administrative grant that can be applied for if it is available. Also, the HMIS grant renewal will not complete this application process but will be evaluated on the data standards and it's Annual Progress Report by the Leadership Committee. Any expansion of HMIS will need to complete a new project application.
